**NOTIFICATION**

In order to facilitate and streamline the procedure for sanction / disbursement of the incentives to the eligible IT/ITES/ESDM entrepreneurs as per ICT Policy 2014, the Government after careful consideration have decided to amend the Para-7 of the ICT Policy 2014 by delegating the power to Secretary, E&IT and Chairman, OCAC as the Competent authority to sanction various incentives to the eligible entrepreneurs provisioned under ICT Policy 2014. All such admissible incentives sanctioned / released at the level of the Secretary, E&IT and Chairman, OCAC shall also be placed before the Apex Committee already constituted by Government under the Chairmanship of Chief Secretary vide E&IT Department Notification No.2126 dated 25/07/2015 for perusal. The disbursement of the incentive by OCAC will be in the chronological order of the approved claims. The Single Window Portal being developed by IPICOL shall be used for filing online application for incentives.
